This indenture made at penreth the xviiij day of Auguste the yher~ of the regne of kyng henre the
 sexte xxxiiij^{to} . by-twix Hugh
 of Louther~ elder~ Squyer~ apon that one parte . And william Lancastre of Hertsopp~ Squyer~
 Apon that other~ partye . berys wyttnes at the sayde
 parties er Acordeit and fully agreit in the maner and fourme at efter~ folowys that es to saye that
 hugh son of the forsayde hugh sall
 wed and with the *grace* of god take to wyfe Mabell doghter~ of y^e sayde william Lancastre by-fore
 the feste of Saynt Michel *Archangele*
 next commyng . And the sayde hugh elder schall infeffe or ger~ infeffe the sayde hugh his son and
 Mabell his wyfe in landes
 and tenementes to y^e valowe of xx . marc~ by 3er~ out our~ all Charge and re pryse with-in viij
 dayes after the weddyng had by-twix
 the sayde hugh and Mabell to haue and to halde all the sayde landes and tenementes to y^e saide hugh
 and Mabell his wyfe and to Ayres [~~ill~~>ill>]
 of thayer~ two bodys lawfully begettyn~ . And that y^e saide william~ Lancastre schall infeffe or ger~
 infeffe the forsaid hugh 3onger~ and
 Mabell his wyfe in landes and tenementes to y^e valowe of x *marces* by 3er~ out our~ all Charge and
 reprise with in viij. dayes efter~
 the weddyng had by-twix hugh and Mabell & *cetera* to haue and to halde all y^e saide landes and
 tenementes to y^e saide hugh and

 And out our~ y^{is} the saide hugh es Agreit that he schall make none Alienacion~ of nother landes nor



tenementes that til hym descendes
by hys Fader~ nor by hys moder~ in fee nor in fetaylle . excepte the landes and tenementes to the
valowe of xl marc~ by 3er~ to be
made to certane persons for terme of lyffe And also the saide william es Agreit that he schall nott
make none Alienacion of no
landes nor tenementes in fee nor in fetayle that he hase in Stirkeland ketill nor dent nor Sedbergh
except~ the landes of x marces
to be+gevyn~ to y^e forsaide hugh 3onger and Mabill his wyfe . And as for the Costage to be made
the day of the weddyng
the sayde parties sall bere .^[ye] charge euenly And as for the coste to be made for a+bull of
